Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.technoinstruments.in, and Techno Instruments and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Techno Instruments include www.technoinstruments.in and Techno Instruments . The Techno Instruments website is a ecommerce site. By using the Techno Instruments website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Techno Instruments may collect personally identifiable information, such as your:
